Independence

Since 1987, the PCA program has been helping people with disabilities across Massachusetts to live more independent lives.

A program of Tempus Unlimited, Inc. (formerly CPMA) funded by MassHealth, the Community Services PCA program provides Skills Training and Functional Evaluation with consumers applying for or participating in the Personal Care Attendant (PCA) program. PCAs offer physical assistance to people with disabilities living in the community.

From bathing to grooming to dressing and helping with medications, PCAs give consumers the help they need to remain in their own home, or even move from a restrictive living situation to a more independent one.

Is the PCA program for you?

Participation in the PCA program is available to consumers who:

- Have MassHealth standard or CommonHealth
- Live or plan to live in the community
- Have a physician's referral to receive PCA services
- Have a permanent or chronic physical or developmental disability
- Need physical help with two or more activities of daily living, such as bathing, dressing, toileting, eating, mobility, passive range of motion exercises or taking medications
- Have the ability, with training, to manage their PCAs or have someone who will act as a surrogate

Support

Through the Tempus PCA program, your PCA can help you with tasks such as:

- <u>Mobility</u>: including transferring, walking, or help using prescribed medical equipment
- Medications: help taking medications prescribed by a physician
- Passive Range of Motion: help with completing prescribed passive range of motion exercises
- **<u>Bathing and Grooming</u>**: help with personal hygiene and grooming
- **Toileting:** help with bowel and bladder needs
- **Dressing:** help with dressing and undressing
- **<u>Eating</u>**: help with eating, including assistance with tube feeding and special nutritional or dietary needs
- Household Services: meal preparation, housekeeping, laundry, shopping, and other special needs approved by MassHealth

The Tempus Unlimited, Inc. PCA program has staff who speak a number of languages, including Spanish, Arabic, Portuguese, Cape Verdean-Creole, Haitian-Creole, Chinese, and Russian.

Consumer Direction

As the employer of your personal care attendant, you will recruit, hire, fire and train your own PCAs. A PCA may be a family member except the spouse of the consumer, the parent of a minor consumer including an adoptive parent, any legally responsible relative/guardian or a surrogate.

To help you learn to manage the PCA program, a Skills Trainer will train you and/ or your surrogate to recruit, check references, hire, train and supervise your PCAs.

Supported Living Program

For individuals in need of additional assistance, Tempus Unlimited, Inc. Services offers the Supported Living Program.

Following approval from a state agency such as the Mass Rehabilitation Commission or the Department of Developmental Services, a Case Coordinator will meet regularly with each consumer to help with such tasks as finding accessible, affordable housing; hiring and managing PCAs; paying bills; coordinating transportation; and arranging therapy or medical care.
